If the contestant exceeds the specified weight limit their entry will become invalid, forfeiting the entry/entry fee.

Contestants must pre-register and pay an entry fee of \$25.00. Deadline to register is 6:45pm Saturday, October 6, 2018 prior to the event starting. Entry fee must be paid **DAY OF EVENT**. All Contestants must wear jeans, long sleeve shirts, boots, protective head gear and chest gear. Protective head and chest gear will be provided by GCFA. If a child brings their own protective head & chest gear, it must be approved by GCFA Mutton Bustin' officials. No spurs or ropes allowed.
